you will receive. If your award changes, you will be notified by email and referred to the student portal (My MCC) for updates/changes to your award offer. Refer to your award letter for information about additional loans and work-study.

- Activate your student email immediately and check it often as this will be the primary way the MCC Financial Aid Office will communicate with you.
- Financial aid award offers are based on full-time enrollment (12 credits). If you register for less than full-time, your award amounts will be adjusted to reflect your actual enrollment.
- Changes to your enrollment affect your financial aid. If you change your enrollment, check with financial aid **BEFORE** you spend your refund! Overpayments must be repaid and overdue accounts will be referred to collections. Aid for late start classes may be disbursed at a later date.
- **LOAN BORROWERS:** Please verify disbursement dates on the Financial Aid Calendar. If you are a first-time borrower, your first loan payment/refund is issued at a later date. Please plan accordingly.
- **REFUNDS:** Your refunds will be processed after the published census date each term. You must make your refund selection **BEFORE** funds are issued to avoid delays in receiving your refund \$\$\$\$. Please log into the student portal to verify your mailing address and contact information.
- You may be assessed a charge to replace lost or stolen refund cards.
