# 2021-2022 Financial Aid Calendar



You must remain in good standing to remain eligible to receive financial aid each term. After grades are posted, the financial aid office will evaluate your status and send you notification.

### HELPFUL TIPS:

• Your initial financial aid award offer will be the **only paper copy** of your award offer that you will receive. If your award changes, you will be notified by email and referred to the student portal (My MCC) for updates/changes to your award offer. Please attend the mandatory work study orientation to accept your work study offer. If you were not offered work study, but would like to be considered, please call the financial aid office and request to be added to the Work Study Waitlist.

• To accept your loan, log into MyMCC to read and accept the complete Terms and Conditions. You must accept Terms and Conditions before you can accept a student loan offer. Initial loan offers are based on year in college and do not include additional unsubsidized loan funds. Please contact the Financial Aid Office if you are interested in borrowing additional student loan funding up to the amounts listed below.

Year	Dependent Students (except students whose parents are unable to obtain PLUS Loans)	Independent Students (and dependent undergraduate students whose parents are unable to obtain PLUS Loans)
<b>First-Year Undergraduate: Annual Loan Limit</b>	\$5,500-No more than \$3,500 of this amount may be in subsidized loans.	\$9,500-No more than \$3,500 of this amount may be in subsidized loans.
<b>Second-Year Undergraduate: Annual Loan Limit</b>	\$6,500-No more than \$4,500 of this amount may be in subsidized loans.	\$10,500-No more than \$4,500 of this amount may be in subsidized loans.
<b>BSN Students that Qualify as Third-Year Undergraduate: Annual Loan Limit</b>	\$7,500 per year-No more than \$5,500 of this amount may be in subsidized loans.	\$12,500-No more than \$5,500 of this amount may be in subsidized loans.

- **ACTIVATE YOUR STUDENT EMAIL IMMEDIATELY AND CHECK IT OFTEN AS THIS WILL BE THE PRIMARY WAY THE MCC FINANCIAL AID OFFICE WILL COMMUNICATE WITH YOU.**
- Most financial aid award offers are based on full-time enrollment (12 credits). If you register for less than full-time, your award amounts will be adjusted to reflect your actual enrollment. Contact financial aid to determine actual amounts.
- Changes to your enrollment affect your financial aid. If you change your enrollment, check with financial aid BEFORE you spend your refund! Overpayments must be repaid and overdue accounts will be referred to collections. Aid for late start classes may be disbursed at a later date. Failure to attend, withdrawal from courses, and/or failure of courses may result in required repayment of aid. When possible, ALWAYS check with a financial aid advisor before making changes to your schedule.
- **LOAN BORROWERS:** Please verify disbursement dates on the Financial Aid Calendar. If you are a first-time borrower, your first loan payment/refund is issued at a later date. Please plan accordingly.
- **REFUNDS:** Your refunds will be processed after the published census date each term. You must make your refund selection BEFORE funds are issued to avoid delays in receiving your refund \$\$\$\$. Please log into the student portal to verify your mailing address and contact information.
- You may be assessed a charge to replace lost or stolen refund cards.
