

NUR 4010 Community Health Nursing (6 credits) 45 practicum hours* Upper division nursing elective (3 credits)

TOTAL: 9 credits

NUR 4008 Legal and Ethical Issues Related to Professional Nursing Practice (3 credits)

NUR 4009 Leadership in the Nursing Profession (3.5 credits) 22.5 practicum hours*
