### ELIGIBILITY REQUIREMENTS

The following must be true:

1. You are a Colorado resident for tuition-paying purposes (you must be eligible to receive Colorado Opportunity Fund (COF)).
2. Your program of study is a short-certificate program(s) approved by a governing board. CTE programs that have been approved by the US Department of Education for Title IV aid are not eligible.
3. You demonstrate financial need by providing documentation that you are currently eligible for at least one of the following:
  - A Pell-eligible Expected Family Contribution as demonstrated by the FAFSA;
  - A Pell-eligible Expected Family Contribution as demonstrated by the Income Form for ASSET Students only;
  - Temporary Assistance to Needy Families (TANF) Benefits;
  - Supplemental Nutrition Assistance Program (SNAP) Benefits;
  - Supplemental Security Income (SSI) or Disability Benefits;
  - Section 8 Housing Vouchers;
  - Women, Infants, and Children (WIC) Benefits;
  - An income that is eligible for Free and Reduced Lunch Benefits;
  - An income that is too low to require a Federal Income Tax Filing.
4. You are not receiving VA benefits or other outside sources such as WorkForce that cover program costs.
5. You are in good standing and demonstrate academic progress according to the institution's published policy of Standards of Satisfactory Academic Progress for financial aid purposes.
6. You have a high school diploma or recognized equivalent; you have not earned a bachelor's degree or higher.
7. You are registered with the Selective Service System, if required.
