**HELPFUL TIPS:**

***• Your initial financial aid award offer will be the only paper copy of your award offer that you will receive. If your award changes, you will be notified by email and referred to the student portal (My MCC) for updates/changes to your award offer. Refer to your award letter for information about additional loans and work-study.***

- Log into MYMCC to read and accept the complete Terms and Conditions of your aid offer.
- Activate your student email immediately and check it often as this will be the primary way the MCC Financial Aid Office will communicate with you.
- Most financial aid award offers are based on full-time enrollment (12 credits). If you register for less than full-time, your award amounts will be adjusted to reflect your actual enrollment. Contact financial aid to determine actual amounts.
- Changes to your enrollment affect your financial aid. If you change your enrollment, check with financial aid BEFORE you spend your refund! Overpayments must be repaid and overdue accounts will be referred to collections. Aid for late start classes may be disbursed at a later date. Failure to attend, withdrawal from courses, and/or failure of courses may result in required repayment of aid. When possible, ALWAYS check with a financial aid advisor before making changes to your schedule.
- LOAN BORROWERS: Please verify disbursement dates on the Financial Aid Calendar. If you are a first-time borrower, your first loan payment/refund is issued at a later date. Please plan accordingly.
- REFUNDS: Your refunds will be processed after the published census date each term. You must make your refund selection BEFORE funds are issued to avoid delays in receiving your refund \$\$\$\$. Please log into the student portal to verify your mailing address and contact information.
- You may be assessed a charge to replace lost or stolen refund cards.
