

## PETITION FOR IN-STATE TUITION CLASSIFICATION

The Petition for In-State Tuition is for Morgan Community College students who are currently classified as a non-resident (for tuition purposes) who may now qualify for resident tuition and wish to have their eligibility reviewed. Students must have taken courses within the last year at Morgan Community College to petition for in-state tuition.

If your tuition classification was based on information provided on your admissions application and you feel the tuition classification was based on incomplete or inaccurate information, you will need to complete the Correction for Tuition Classification form for tuition classification changes.

DEADLINE: Tuition correction requests are due by the drop/add (census) date for the semester. Failure to do so will result in non-resident classification for the semester. Published deadlines are listed on the Academic Calendar.

GUIDELINES: Petition for In-State Tuition must be completed in its entirety. Residency for students under 23 is based on parent or court-appointed guardian unless student is an emancipated minor.

NOTE: If the student is under 23 and is not emancipated or if the student has turned 23 during the last twelve-months and was not previously emancipated, the parent or court-appointed legal guardian of the student must complete this petition. If a parent or court-appointed legal guardian completes this petition, the information provide must reflect the situation of the parent or court-appointed legal guardian rather than the student

## **EXPLANATION**

Some forms of evidence of being a Colorado resident include: Colorado Driver's License or Colorado ID, Colorado State Tax Returns, Colorado Motor Vehicle Registration, Colorado Voter Registration, Employment in Colorado, Lease or Purchased a home in Colorado.

Residency classification for tuition purposes is governed by Colorado Revised Statutes 23-7-101 et sesq. The statute provides that the burden of proving a Colorado domicile rests squarely upon the petitioner. It is the petitioner's responsibility to provide adequate information and supportive documentation as required by the 'registering authority' (Morgan Community College). The registering authority, on the basis of the written information and supportive documentation supplied with this petition will make the determination of domicile for tuition purposes. You must answer ALL guestions and attach supportive documents. Failure to include any required document may render the petition invalid or make it impossible for an appropriate decision to be made.

This petition must be completed and submitted to the registering authority by the deadline established by the college.
